



## **What is the Wraparound Process?**

Wraparound is a strengths-based, care coordination process that is a central part of YES Waiver services. A Wraparound Facilitator works with you and your child to create a Child and Family Team (CFT), which meets monthly, and may include family, friends, neighbors, professionals, and others who are important in your youth's life. Together, the CFT helps your family achieve your vision of success and build a foundation of support that will be there even after your child has graduated from YES.

## **How long does YES Waiver last?**

The average length of time in the YES Waiver is 11 to 18 months. Your youth's needs will determine the program duration.

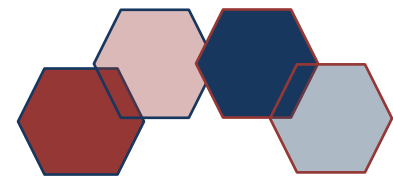

## What is the YES Waiver?

The Youth Empowerment Services (YES) Waiver is a 1915(c) Medicaid program that helps children and youth with serious emotional and behavioral difficulties. The YES Waiver provides intensive services delivered within a strengths-based team planning process called Wraparound.

YES services are family-centered, coordinated and effective at preventing out-of-home placement and promoting lifelong independence and self-defined success.

## Goals of the YES Waiver

- Reduce the amount of time children and youth are out of their home and community because of a mental health need.
- Expand available mental health services and supports.
- Improve the lives of children and youth.

## Youth in the YES Waiver:

- Are between 3 through 18 years of age.
- Have serious mental, emotional and behavioral difficulties.
- Have a qualifying mental health diagnosis.
- Are at risk of being removed from their home due to their mental health needs.



## Who Do I Contact about Receiving YES Waiver Services?

Services are accessed through the YES Inquiry Line at the Local Mental Health Authority (LMHA), Pecan Valley Centers for Behavioral and Developmental HealthCare.
